Nice shot of needed moisture on Palm Sunday and Easter Sunday. Hope everyone that is fortunate enough to have and take care of a horse pasture was able to get fertilizer spread in time to take advantage of it. I know that getting my fertilizer spread, dragging my pasture and re-corrugating has kept me a bit busier than I (and the dogs) like.

As you may have heard by now, the Forest Service took a big hit in their budget for the rest of the Fiscal Year. According to the Theodore Roosevelt Conservation Partnership: "Wildlife and Fisheries Habitat Management, and Recreation, Heritage, and Wilderness initiatives of the USFS received cuts of up to 20%. The Recreation, Heritage, and Wilderness initiative provides funds for improving access to and recreation on USFS land, including planning resources, trail management, and the off-highway vehicle program."

We were able to set up a meeting with Forest Supervisor, Ken Coffin and Mike LaFrentz (Forest Staff Officer) to get input on what that may mean regarding trails work and staffing on the Forest this year. Unless something unexpected happens, our Watch Dog and Service Committee Chairs should be able to update the membership on this during our April meeting.

I'd like to thank Kristin Alcala and Carolyn Danko for volunteering to perform the audit of the Chapter books.

Kudos are also in the offering for all the time Board members and Officers have spent on providing input on our new Procedures and Methods write-up. I look forward to bringing the membership up to date with our progress and our plans for disseminating this information to the membership at our April meeting.

Secretary's report by Randi Slaughter

Minutes of Meeting 03/21/2024

Meeting began: 6:32pm

Cindy Geisler requested that a motion be made to cast a unanimous ballot to elect the candidates recommended by the Nominations Committee at our February meeting. Howard Sanders moved, Kristin Alcala seconded. Motion was passed unanimously.

Mike Blymyer then took over the meeting as the now elected President.

Secretary's Report: Kathi Gimmeson moved to accept the minutes as published in the March, 2024, newsletter. Kristin seconded. MSP

Treasurer's Report: Howard moved to accept the Treasurer's Report as published in the March, 2024, newsletter. Connie Jack seconded. MSP

Kathi presented the following bills to be paid: Newsletter printing \$7.92, Newsletter postage \$68.00, Brochure printing \$58.24, Water for Potluck \$3.99, Candy for Sunlight Sports Community Night \$8.75, totaling \$146.90. Carol Olsen moved to pay the bills, Joe Childers seconded. MSP

Committee Reports

Watchdog: Mike noted that Linda Putney had been appointed the Chairman of the Watchdog committee, then turned the report over to her.

She first provided the good news that the Fiscal Year 2024 Interior, Environment and Related Agencies Appropriations Act provides \$41.2 billion in total funding, which includes \$6.07 billion for the Forest Service, excluding additional funding for the Wildfire Suppression Operations Reserve. This includes an amount for current staffing levels, and fulfills the annual commitment for projects to improve forest landscapes, as well as the Legacy Roads and Trails program to prioritize fish passage improvements and repurposing unnecessary roads as trails.

Additionally, the Outdoor Recreation and Tourism Trust Fund Administration (HB 67) now has a governance structure to allocate grants from the \$6 million held. The Park County Outdoor Recreation Collaboration, of which SBCH is a member, will be applying for these funds. Projects include a new boat launch ramp in Powell, improvement and expansion of the Outlaw trails, and other suggested projects.

Activities: Von Ringler turned this over to Cathy Ringler, but there was nothing to report.

Education: Cathy noted that the Youth and Packing clinic is getting a good response. There are 12 kids signed up, about equally split on the age groups, and 10 packers. They plan to work on skills in the morning, and have games on horseback in the afternoon. Jesse and Kristin are doing hotdogs, hamburgers and chips.

Service: Howard talked about First Aid training, which should be repeated every 2 years. Everyone cleaning trails and basically involved in all activities needs training. The class offered by the Forest Service will be held May 1 at 9:00am, in the Firefighters warehouse across from the airport. The Forest Service does not issue cards. The class should be done by noon. Those that need initial saw training can stay for that in the afternoon.

If you are not running a hand saw over anything bigger than five inches, there is no need for certification. Also there is "sawyer in training" for those too young for certification. Recertification will be offered sometime after the 15th of April. There are several members in need of recertification. Howard let everyone know who still has valid certification and who needs recertification. You need to fill out a form for the Forest Service to put in the Forest Service database.

Prior to doing work in the woods, everyone cleaning trails needs to review the risk assessment and put your name on it to be turned into the Forest Service. The reason for doing this is if we are following all the rules and you get injured, but your insurance does not cover it, then the government will pick it up under the equivalent of Workman's Comp.

Frank Fagan will take the lead on trails on Sunlight. Big Creek leaders are Hannah Weed and Steve Brock.

Publicity: Kathi had no updates but asked for any pictures and articles for the next newsletter. She mentioned that the new brochures say who we are, what we do, and include information on Leave No Trace and Trail Etiquette.

Social Media: Randi Slaughter reminded everyone to send her photos. She also noted to all that Facebook posts for our chapter only should go into the private group. Announcements and interesting material for the public should go on the home page and Instagram.

Recruitment: Connie is reaching out to folks further east of Cody and Powell, and asked to let her know any names you might have. She has been texting people that haven't shown up.

Secretary's report cont.

Barry Reiswig participated in the State Public Lands Backcountry Horsemen conference that included chapter representatives from North Dakota, South Dakota, Montana, Colorado, and Wyoming. He reported that the Forest Service funding for trails remains the same, which at least is better than having it cut. There is an effort to restart work on the Continental Divide Scenic Trail, trying to reorganize and get the trail finished. The stretch in Montana needs the most work. The Forest Service has 700 positions in trails, with 400 of them vacant. 49% of all maintenance on trails is done by volunteers. There is a bill in Congress for a wide range of recreation funding. They are also trying to get rid of wilderness study areas in Johnson, Washakie, Hot Springs and Natrona counties. The badlands near Gillette did get protected.

He pointed out that when you are working for the Federal government, budgets have to be in place before posting and advertising positions.

We belatedly welcomed new member Brad Meredith.

Old Business: Audits of the books. Asked for another volunteer for the audit and Carolyn Danko stepped up.

Policies and Procedures Manual: Mike noted that first we have to systematically address this. Currently the Board is moving in the direction to focus on adding to position descriptions as they exist in the current By-Laws. They are not looking to renew or modify the By-Laws. Modifications will be done informally through procedure manuals. The Board is looking through the By-Laws to see what needs to be expanded. It will all be presented to the members. There was a suggestion to put it on the web page. We may need to have a couple of printed copies for the members that cannot get on the internet.

Dano Fund Raiser: The donation to Dano is \$2500. Dano has requested that the drawing and check presentation be at Sunlight Sports' Community Night on April 11. Thanks was given to Frank for his work both on the table and selling the raffle tickets. Kathi mentioned that SBCH will have a table there that night.

New Business: Linda requested a new computer for the treasurer. The computer that has been passed down was donated to the club in 2005 or 2006, but she had been using her own laptop. The old one will not run some of the programs needed. The request is that we buy a new one with updated technology and security. Linda checked Costco and Coulter Bay for prices, but noted that she prefers Costo for their concierge program which provides 24/7 help. Eugene Brumbaugh moved to budget \$1000 to acquire a computer for the Treasurer, Howard seconded. Motion passed on voice vote.

He is not taking any more repairs after either this week or next week. Jim asked to know when the shop closes so the ad can be removed from the website. He is not selling the shop, just closing it. He has other projects he is working on.

Howard moved to adjourn, Jesse second MSP. Meeting adjourned at 7:23pm.

Of course, we will be in contact with you to talk about how to use those credits best.


We're excited to see you at Community Nighton April 11th! It's going to be a great opportunity for you to explain exactly what you do to our community and why they should support you.


